Brief Resume of Duty Assignments: Attended Basic and Advanced ROTC training at Yale Univ. from 1940 - 1943. Graduated from Yale Univ. with the class of 1944. Immediately went to Fort Sill for OCS and successfully completed training and was commissioned a 2LT. In 1944 he was assigned to a 105 How BN of the 27th INF DIV, South Pacific.

Served as a FO with the 3rd BN, 105th INF Regt of the 27th DIV on combat duty in Okinawa. Assaulted the small island of TSUGEN JIMA.

While in Okinawa he was promoted to 1LT. Continued to serve with the 27th DIV during combat duty and eventually moved to Tokyo for occupation duty. Promoted to CPT and joined GEN MacArthur's HQ on occupation duty. Separated in March 1946.

Awards and Decorations:

1. Battle participation campaign star for RYUKYUS (Okinawa) 26 Mar - 2 July 1945
2. Occupation of Japan medal
3. Awarded the Medal of Freedom by President Reagan in 1988

General Remarks: Hopefully my brother "MAC" is eligible for Fort Sill's OCS Hall of Fame under the National Prominence qualification. He rose to national prominence as a businessman, a corporate leader and President of Eastern Malleable Iron, Co and later Scovill Mfg Co. President Reagan appointed him to the position of ~~Secre~~ Secretary of Commerce, he served with distinction for seven years until his death in a horse accident.
