MILITARY HISTORY: Colonel Booth, a veteran of World War II, began his military career by enlisting in the Louisiana Army National Guard upon graduation from Warren Easton High School, New Orleans, on 19 July 1939. He entered Federal service 13 January 1941 as a member of the 141st Field Artillery Regiment (Washington Artillery), completed OCS, Fort Sill, Oklahoma and was commissioned a Second Lieutenant, Field Artillery, in 1943. Went to European Theatre of Operations in July 1944 and served as an Artillery Battery Commander with the 980th Field Artillery Battalion, VII Corps Artillery until return to the United States in November 1945. Released from Federal service 6 February 1946. In December 1946 appointed First Lieutenant, Army National Guard of the United States with the Louisiana

Army National Guard and assigned as Commanding Officer, Service Battery 141st Field Artillery Battalion. Promoted to Captain 15 June 1948. Accepted full time employment in the Military Department of Louisiana at Jackson Barracks and assigned as Assistant G-3 in May 1949. Served as Commanding Officer, Headquarters Detachment LaARNG, for a period of five years under two different Adjutant Generals from 1951 to 1956. Promoted to Major August 1957. In addition to his full time occupation as Operations Officer he served as Executive Officer for three years and four months with the 21st Special Forces Group (Airborne), August 1959 to April 1963, during which time he was promoted to Lieutenant Colonel, 16 August 1961. He was promoted to Colonel 1 February 1966. He has served as Director, Operations and Training, Military Department, State of Louisiana, for the past eighteen years under five different State Adjutant Generals, thru 31 January 1976; retired on this date for reason of mandatory age limit, 55 years, in grade of Colonel.
