BRIGADIER GENERAL ROBERT K. ELLIOTT

Brigadier General Robert K. Elliott is Mobilization Assistant to the Staff Judge Advocate, Air Force Systems Command, Andrews Air Force Base, Md.

He was born August 22, 1921, at Liberty, Mo. He graduated from the University of Missouri at Columbia in 1943 with a bachelor of science degree in public administration. He received his Juris Doctor Degree from the University of Missouri at Columbia Law School in 1948. He is a graduate of the Industrial College of the Armed Forces in May 1962 and an Honor Graduate of the Annual Reserve Refresher Course at the Army Judge Advocate School, University of Virginia, at Charlottesville, in 1969.

General Elliott received his commission as a second lieutenant in December 1943, after completion of Reserve Officer Training Corps at the University of Missouri, and Officer Candidate School. Following pilot training he served as an observation pilot and as a flying instructor.

In 1946, he was released from active duty and joined the Air Force Reserve. His service as a Reservist included assignment as a Staff Judge Advocate for the states of Missouri and Iowa, in the 2483rd Air Reserve Sector from 1960 to 1965, at which time he was assigned to the Staff Judge Advocate at Headquarters, Air Force Communications Service, Scott Air Force Base, Ill. General Elliott continued in his assignment when AFCS moved to Richards-Gebaur Air Force Base, Mo., in 1970.

In March 1974, General Elliott was assigned to his present position. As a part of his duties with the Air Force Communications Service, he supervised the legal aspects of the USAF Military Affiliated Radio Service program, and was the author of an article in the May 1973 issue of the Air Force Judge Advocate Law Review. General Elliott was instrumental in setting up a pilot program at Richards-Gebaur for the Defense Department to provide legal aid for indigent service personnel wherein active duty military lawyers were allowed to practice law in Missouri state courts.

His military awards and decorations include the Meritorious Service Medal, World War II Victory Medal, American Campaign Medal, and Armed Forces Reserve Medal.

Since 1958 he has been a Judge of the Seventh Judicial Circuit Court of Missouri and serves as Judge of the Juvenile Court as a part of his duties. He has been a member of the Executive Committee of the National Juvenile Court Foundation. His previous offices include that of President of the Missouri Council of Juvenile Court Judges, and President of his local Bar Association. He is admitted to practice before the Court of Military Appeals and the Supreme Court of the United States.

General Elliott is a member of the Air Force Association, Reserve Officers Association, and a member of the Missouri Task Force on Juvenile Delinquency. He served as a faculty member of the National College of the State Judiciary, University of Nevada, in 1968, and as a lecturer and seminar leader at various other judicial seminars, including a Military Judges Seminar held at Richards-Gebaur Air Force Base in 1972. He holds an advanced Class Amateur Radio License and FAA Civilian Commercial Pilot, Instrument Rating, and Instructors Rating.

He was promoted to the grade of brigadier general effective March 7, 1975.
