





The President of the United States of America, authorized by Act of Congress July 9, 1918, takes pride in presenting the Silver Star (Posthumously) to First Lieutenant (Field Artillery) Ernest B. Allen, Jr. (ASN: 0-1177264), United States Army, for gallantry in action while serving with the 35th Infantry Division, in action near \*\*\*\*, Belgium, on 13 January 1945. When his battery was subjected to an intense enemy artillery barrage while on a convoy move, Lieutenant Allen, with utter disregard for his own safety, made his way toward several wounded men lying in exposed positions while shells were falling all about him, but was killed before he could administer aid to the wounded soldiers. His inspiring display of intrepidity and unselfishness on this occasion characterized the high type of leadership for which Lieutenant Allen had been known throughout his service in combat, and reflects high credit upon the military service.



**World War II DeRidder Army Air Base Memorial** is located on Hwy 190 West, (Atakapa Coushatta Trace) just north of the Beauregard Parish Airport. The Army Air Force (AAF) was organized in June 1941 and by December 25, 1941, the first unit arrived at the DeRidder Army Air Base (DAAB).

Not all airmen boarded the train to start the long journey overseas. While serving their country, 35 men lost their lives in training accidents in and around the DeRidder Army Airport and Gunner Range that is located south of Merryville, 1942 - 1945. Such accidents resulted in men succumbing to death by "burning in airplane," "hung in tree after airplane crash," "air accidents," and other accidents.

# 80 NAZIS SEIZED BY WILLCOX MAN

#### Killed In Auto Accident Following Wholesale German Capture

WILLCOX, Oct. 7.—(P)—Eighty German soldiers and three officers were captured near Souppes Sur Loing, France, August 22, by Lt. Alex L. Armagnac of Willcox and a companion corporal while on advance patrol duty, the officer's mother, Mrs. A. O. Rix, learned here.

Mrs. Rix received a silver star citation awarded her son five days before she was advised by the war department he had been killed in a motor vehicle accident.

The exploit paralleled to a great degree that of Sergeant York of World War I fame.

Count Defenses

Armagnac and the young corporal were assigned to count defensive positions near the town, first accompanied by two tanks. Nazi anti-tank fire broke up the advance temporarily, but Armagnac moved ahead along, spotting emplacements from rooftops and other vantage points.

#### Gives Location

He communicated the whereabout of the tank-busters to a liaison pilot and four were destroyed. Then the officer and the enlisted man crawled forward, picking up three enemy soldiers and a lieutenant at the spot where the wrecked guns were situated.

The lieutenant, who was caught attempting to escape by automobile, informed Armagnac that more Nazis, some of them wounded, were holding a nearby height and probably would be in a mood to surrender. The two Americans advanced again, capturing another bunch of Germans led by a captain. The captain gave up only after Armagnac leveled a sub-machine gun in his direction. Sight of the weapon loosened the Nazi officer's tongue. He told Armagnac of still another detail of enemy. The men, including a major, were caught by surprise. They submitted upon Armagnac's promise that the dead and

wounded would be cared for.

death a few days later.

Armagnac, married and the father of a four-year-old daughter, was engaged in business in Willcox before volunteering for service. He was a graduate of Willcox High School, Roswell Military Academy and attended the Univzersity of Arizona.







Still in High School when he joined the National Guard. The Guard mobilized September 16, 1940 and he was assigned to the 158th Field Artillery Group, 45th Infantry Division and assigned To Panama. He returned To Fort Sill, Oklahoma, where he attended Officer Candidate School (OCS) and commissioned a 2nd Lieutenant in the Army. From there he went to North Africa in 1944 and assigned to combat duty. Participated in the Anzio Beachhead. He was with the 160th Field Artillery for the Rome-Arno Invasion and participated in the Southern France Invasion. One of nine pilots to fly off LST on the Southern France Invasion. He was awarded the Air Medal, Purple Heart, Silver Star, 2 European Theatre Medals with Numerous Battle Stars, American Defense Medal and The Distinguished Flying Cross. Three of these Medals were awarded posthumously to his parents at Fort Sill, Oklahoma, as he was killed in combat during WW II. He was a pilot serving with the Artillery as a Forward Observer, near Dijon, France and heading back to base when 2 Messerschmitt's got on him. To avoid leading them to the base he flew in a different direction. They fired on his plane and got a direct hit. He was able to land the crippled plane, but it was engulfed in flames. His crewman was badly injured and unable to get himself out. He pulled him out and to safety but incurred burns himself all over his body. This was on September 19, 1944. He died the next day, September 20, 1944.

Just a few weeks before, he had received National attention when he landed his plane behind German lines to rescue a grounded New Zealand pilot. He was brought home to Weatherford, Oklahoma and buried.

# State Mother Gets Hero Son's Medal

PORT SILL, Jan. 20.—(PAS)—The Distinguished Flying Cross, awarded posthumously to First Lieut. Paul V. Avritt, field artillery liaison pilot, was presented to his mother, Mrs. Mattie D. Arvill of Weatherford, by Maj. Gen. Ralph McT. Pennell, commandant of the field artillery school, at ceremonles Saturday evening at 6 o'clock on the post field parade ground here.

Lieutenant Avritt, a graduate of the officer candidate school and liaison pilot course at Fort Sill, was awarded the Distinguished Flying Cross for "extraordinary achievement" in France when he rescued a "Spitfire" pilot who had been forced down behind enemy lines.

"While participating in aerial flight on 30 August 1944, in the vicinity of —, France," the citation reads, "Lieutenant Avrill, while flying behind enemy lines, noticed that a 'Spitfire' had been hit by antiaircraft fire while strafing an enemy column, and was being forced to make a landing in an open field that was entirely controlled by the enemy.

"Lieutenant Avritt, completely ignoring all personal danger and aware that he was in enemy territory, made an emergency landing, rescued the uninjured pilot and returned him safely to the Division Artillery air strip."

Lieutenant Avritt, who subsequently died of wounds, was born January 2, 1921. He was graduated from the field artillery officer candidate school and received commission as a second lieutenant on March 11, 1943. Later he took liaison pilot training and was graduated on July 9, 1943.





The President of the United States of America, authorized by Act of Congress July 9, 1918, takes pride in presenting the Silver Star (Posthumously) to First Lieutenant (Field Artillery) John F. Bariani (ASN: 0-1185434), United States Army, for gallantry in action while serving with the 216th Field Artillery Battalion, 35th Infantry Division, in action near \*\*\*\*, Germany, on 31 March 1945. When an outpost of an infantry unit reported two enemy machine guns emplaced to the front, Lieutenant Bariani, a forward observer, voluntarily made his way ahead of our lines and to a position within fifty yards of the enemy guns when he was pinned down by enemy fire, and an enemy rocket-launcher team moved toward him. He waited until the team neared his position, then directed artillery fire which destroyed the rocket launcher and its crew. Remaining in his forward position, he directed artillery fire in the destruction of the enemy machine gun emplacements before returning to his original position. Lieutenant Bariani's bravery, coolness under fire, and accurate fire direction, honor his character as an officer.



#### From the August 17, 1944 Nanty-Glo Pennsylvania Journal:

Lt Bartok was born on February 12, 1912. He graduated from Blacklick Township High School and later studied navigation and flying at Harrisburg and Butler before entering the Army about three eras ago, being employed by the Social Security department at the time. He trained at Camp Lee, Virginia and Fort Benning, Georgia, then went to officers' candidate school at Fort Sill, Oklahoma, where he was commissioned as an artillery officer. He went overseas to England a few months ago and then to Normandy.

Relatives received a letter from him dated July 11, in which he wrote "Yesterday I spent all afternoon digging a new and better foxhole. I will be an expert ditch digger when I get out of the Army. I have shoveled more dirt since I came to France than I did all the rest of my life. The good advice here is 'Dig or die.' I prefer to dig." He did both.





The President of the United States of America, authorized by Act of Congress July 9, 1918, takes pleasure in presenting the Silver Star to Second Lieutenant (Field Artillery) Sol Bauer (ASN: 0-1169857), United States Army, for gallantry in action against the enemy while serving with the 90th Infantry Division in Northern France. On 6 July 1944, in the vicinity of \*\*\*\*, France, when a large force of German paratroopers delivered a counterattack, Lieutenant Bauer, disregarding his own personal safety and under heavy enemy fire in an exposed OP, adjusted and delivered such a volume of fire against the enemy that the attack was completely broken up and the attacking force completely dispersed. On 11 July 1944, when our troops were receiving heavy casualties near \*\*\*\*, France, Lieutenant Bauer being unable to locate a satisfactory OP in a concealed position, worked out into the open ground and remained in an exposed position under enemy fire for two hours despite the fact that many casualties were being suffered in his vicinity and members of his party became casualties. He remained in this OP adjusting fire on the enemy until he had accomplished his mission. These gallant acts were in keeping with the highest traditions of the military service.

# Falling Timber Caused Death

The following letter explaining the cause of the death of her son, 2d Lt. William G. Binshadler, has been received by Mrs. Theda A. Binshadler, of Lebanon, from his company, the 661st Ordnance Ammunition company, at Aix en Province, France.

"Dear Mrs. Binshadler: We, the officers and men of the 661st Ordnance Ammunition company feel deeply the loss of your son . . . and wish to express to you our deepest sympathy in your moment of sorrow.

"On Jan. 6, 1945, your son was severely injured in an accident, resulting in his death on Jan. 11. Death was due to a fractured skull, inflicted by falling timbers of a building which blew down while he was at work. He was rushed to a hospital and given the best of medical care, but he never regained consciousness.

"On Jan 18, a full military funeral was held for him, services being conducted by Capt. Ralph M. Anderson, a protestant chaplain. All officers and men of his company, and representatives of higher headquarters attended. He now rests with other American soldiers, who have also given their lives for their dear country, in a small American military cemetery on a grassy knoll overlooking a beautiful countryside in southern France.

"At the present time I am not permitted to give you further details, but when this war is all over, I trust you will call on me for any further details you may desire. With deepest sympathy, I remain, Very truly yours, Warren C. Smith, Capt., Ord. Dept., commanding."

1st Lt. Brandon B. Bodell was a WWII casualty--killed near Metz, France, during Patton's Third Army push across the Moselle River. His bravery and death are recorded below in the 558th Field Artillery History:

- 19 September the whole battalion finally crossed the Moselle. One section from C Battery was attached to the 204th Group for direct lay missions. This gun was commanded by 1st Lieutenant Brandon B. Bodell, who distinguished himself by his gallantry and courage during all these operations.
- 20 September Lieutenant Bodell's gun destroyed a (German) 88mm gun in spite of heavy counterbattery fire.
- 21 September Lieutenant Bodell's gun scored a hit on the North Fort of the Verdun series, causing internal explosions and blowing two ventilators from the roof.
- 28 September 1st Lieutenant Bodell, Sergeant Sanderson, Privates Hall and Vina were all seriously burned when an enemy shell hit the powder at the gun's emplacement. All four died of wounds later in the hospital and all four received the Bronze star posthumously for their actions against the Metz forts.... Lieutenant Bodell's loss was one of the greatest the battalion was to suffer, for his command ability and calm efficiency in the face of the enemy was an inspiration to all... He seemed to have an uncanny knack of inspiring the **men around him...**

# Excerpts from Headquarters 636th Tank Destroyer Battalion Historical Records (Operations in Italy, January 1944)

#### January 21, 1944

Constant contact was maintained with the assaulting Regiment through our Liaison Officers in order that close support might be given. As soon as it was learned that our troops had gained only a small foothold across the River, Companies A and C fired missions on S. Angelo and areas beyond S. Angelo.

At 1100 hours, 1st It John C. Campbell, 0-1168196, our Liaison Officer to the 1st Battalian, 1/1st Infantry called and stated that the 2nd Battalian was going to attack, and as there was no Liaison Officer from our Battalian with it, requested that he be permitted to report to the 2nd Battalian. The Battalian Commander gave his consent and It Campbell reported to the Battalian Commander, 2nd Battalian, 141st Infantry.

At 1130 hours, a message was received stating that the attack was to be resumed at 1400 hours. The Company Commanders were called in and given the new situation by the Battalion Commander. The Battalion Commander directed that Companies A and C continue to lay harassing fire on the enemy positions beyond the area held by our troops at the bridge site. Due to the smoke and haze it was impossible to observe the fires.

During the conference word was received that an allied force had landed south of Rome. At 1306 hours word was received that the attack would not be launched until 1500 hours and the Companies were immediately notified of the change. At 1/30 hours, word was received that the hour of the attack had been changed to 2200 hours and the Companies were notified.

#### January 22, 1944

At 1027 hours, a report was received that 1st Lt John C. Campbell, 0-1168196, Liaison to the 2nd Battalion, 141st Infantry, was killed at 1000 hours by an enemy mortar shell. The Sergeant assisting Lt Campbell on his mission reported that Lt Campbell had left his foxhole to telephone a report to Lt Colonel Filand, the Battalion Commander, and that the shell exploded just to the front of Lt Campbell, as he telephoned.

The Commanding Officer, 141st Infantry called during the afternoon of 22 January and reported that the Battalion's fire was very helpful and seemed to be highly effective. The Battalion Commander assured the Commanding Officer, 141st Infantry, that we would continue to fire on every target that appeared and on those reported to us by the Infantry.

# Rockford Man Is Missing in Pacific Area

With U. S. Army Forces, Bougainville, March 10.—(U.P.—After being lost nearly a month inside Japanese Lines, Lieft Iqkoro, a Fiji Islander, returned to U. S. lines at Bougainville, but hope has been virtually abandoned for his companion, Second Lieut. Charles W. Cross, 23, Rockford, Ill., it was announced here today.

Iqkore and Cross, who was an aerial liaison artillery specialist of the American division, were lost in the clouds January 27 while on an observation mission. They crash landed in Japanese territory unhurt.

After struggling for six days through dense jungle, they finally emerged into a clearing and discovered that they were deep inside enemy territory.

They headed back toward U. S. lines. They had water but no food.

By February 7 Cross was unable to walk further. The Fijian carried him on his back for two days, after which Cross refused to burden him any longer. He insisted that Igkoro continue alone.

After an argument the Fijian built a lean-to and left Cross his clothes and water. Twice Iqkoro returned to Cross but the third time he kept going toward the American lines.

Finally, on February 21 Iqkoro was picked up by some natives who carried him to shelter. There he rested and had food, after which he pushed on until he reached safety.

An American patrol was sent out to look for Cross but found no trace of him.

While serving as an artillery observer to an infantry battalion during an attack on 8 November 1944, Second Lieutenant Dickson advanced into the areas heavily infested with enemy sniper fire in order to obtain better observation. Despite constant enemy observation he courageously and steadfastly continued to direct artillery with marked success until he was killed by an enemy sniper. The personal bravery and zealous devotion to duty displayed by Second Lieutenant Dickson were in keeping with the highest traditions of the military service and reflect great credit upon himself, his unit and the United States Army.

He entered the army at Eagle Pass in November 1941, and at the time of his death was serving with the 314th Field Artiflery attached to the 80th Infantry Division.

He is survived by his wife, Mrs. Gertrude Dickson; two daughters, Marcie and Raye; his parents, Mr. and Mrs. R. E. Dickson; and one sister, Mrs. W. M. Hilley, all of Spur. His father is director of the Texas A&M. Extension Service experimental farm at Spur.





From the 601st website: By October 15th, 1944, the 601st was on French soil. The 601st and 602nd were assigned the northernmost part of the area held by the Allies. They were attached to the "First Airborne Task Force" in direct support to the "509th Parachute Infantry Battalion." They continued to support the 509th until March 15th, 1945, occupying a position near Peira Cava in the Alps near Nice. The 601st stayed in the northernmost position of the mountains of southern France for the winter. A 601st member remembered seeing Captain Charles A. Dieterlen killed on Feb. 24th, 1945. Captain Dieterlen stepped on a land mine, just north of Nice, France.



The battalion consisted of three firing batteries and Headquarters and Service (H/S) Battery. The service platoon transported ammunition and general supplies by means of about 50 pack mules, herded by men on riding mules with use of a bell mare. Smaller numbers of mules, each led by a walking "mule driver", were organic to the communications and fire direction center (FDC) elements. The wire section had three teams, each consisting of two men and one mule, used to lay wire from the FDC to the firing batteries. Each of those mules carried two large reels of wire, mounted on spokes on either side of the packsaddle; from these wire was unreeled at a walking pace. H/S Battery also included the pilots and crews of the two L-5 liaison planes organic to each battalion, plus veterinary, horseshoeing, and saddler personnel.

A firing battery consisted of four howitzer sections. Communication from FDC to the battery executive officer was usually by wire, and from him to the sections was verbal. The section was composed of three elements; one 75mm pack howitzer, eleven men, and ten pack mules.

The howitzer weighed about 1300 pounds and was designed for quick disassembly into approximately ten components, for transport on six mules. Heaviest component was the front trail, at some 240 pounds, followed by the tube at some 220 pounds. Each of these was a full load, and these two required the best mules in the section. Four men, with two steel lifting bars, were required in loading or unloading these two components. At the other end of the spectrum was the mule which carried a combination load consisting of the breechblock (two men and one lifting bar) and the wheels.

One example of the aggressiveness in reconnaissance of the members of the 929<sup>th</sup> Field Artillery Battalion throughout the period of combat operations occurred on 25 November when Captain Albert EISTER and his first sergeant, Homer S. Regan, of Battery A approached a large building of the huge factory in Weisweiler for the purpose of locating gun positions in the nearby field. Two enemy soldiers ran out to man anti-tank guns guarding the entrance to the factory. Capt. EISTER and Sgt. Regan took the two men prisoners and a few minutes later captured three more men in the building. In this advance position the two Americans set up an observation post and then directed artillery fire under cover of which the infantry was able to move in and mop up the area, capturing many prisoners, including three from the first floor of the building in which the observation post was located. Sgt. Regan remained in the building overnight with three other men and continued to direct fire. Their battalion was reinforcing the fires of another artillery battalion in the division, in which case it is not even normal for the reinforcing battalion to send out forward observers to the assault companies.


