

- 3 Feb 41 - 18 Aug 42: Inducted into active military service as EM with the 258th Field Artillery Battalion, New York National Guard.
- 19 Aug 42 - 19 Nov 42: Entered Officers Candidate School, 19 August 1942. Graduated, Class No. 39, Officers Candidate School, Fort Sill, Oklahoma. Commissioned 2d LT Field Artillery, 19 Nov 42.
- 4 Dec 42 - 21 Nov 45: Assigned and joined 231st Field Artillery Battalion, 6th Armored Division, on 4 Dec 42. After training in the desert of California and Camp Cooke, California, the Division departed for Europe on 10 Feb 44, arriving 22 Feb 44. While in the US, assigned as Battalion Adjutant and Forward Observer. Throughout period of combat in Europe assigned as Forward Observer and then Combat Liaison Officer. Returned from Europe on 10 Sep 45, and released from active duty on 21 Nov 45.
- February 1946: Re-entered St. John's University Law School to complete my legal education which was interrupted after 2 years by induction in February 1941. Graduated in August 1946 with an LLB degree. Admitted to practice law in State of New York in December 1946. Practiced law in New Rochelle, New York until October 1947.
